Two Refuse collection sites (Region A and Region B) were tendered for two tenderers (Eclipse Environmental solutions and Blue Hygiene) made it to the financial proposals stage. Eclipse had tendered for both regions whilst Blue Hygiene tendered only for region B. Blue Hygiene was competitive, compared to Eclipse Environmental Solutions on the B region, hence an intention to award B is hereby submitted by the approval authority. There is however, no intention to award region A by the approval authority due to budgetary constraints.

A notice of Intention to award Region B to Blue Hygiene, following a competitive bidding process, in terms of section 45 of the Public Procurement Act No. 7 of 2011 (the Act), is hereby given by the approval authority. A summary of the decision of the intention to award is tabulated below.
