
### SECTION C: INSTRUCTIONS TO TENDERERS AND TERMS AND CONDITIONS OF TENDER

Failure to complete this questionnaire and/or to provide written answers to any further questions or requested additional information for clarification will result in the supplier's disqualification from further consideration. Where necessary and if insufficient space has been provided on the questionnaire for the answers, please provide the answers as supplementary on separate sheets.


