1. This circular has been issued in terms of Sections 66 read with 55 (4) of the Public Procurement Act No.7 of 2011. The Act *inter alia* provides for the suspension of tenderers and suppliers on the grounds specified in section 56 of the Act.
2. Kindly ensure that the above-cited as per the subject do not receive any procurement contract or participate in any procurement exercise during the period of suspension.
3. Any existing contract entered into between the suspended tenderers and a procuring entity prior to the suspension, shall not be ordinarily affected by the suspension to the extent of the suspension period unless on grounds of public policy. Hence, **CONSORTIUM CONSULTING (PTY) LTD T/A LCC CAPITAL CONSULTING** is required to deliver all ongoing contracts in accordance with the agreed terms and conditions.
