SECTIONS 66 AS READ WITH SECTION 20 (c), 46 (2), 48 (2), 57 (7), OF THE PUBLIC PROCUREMENT ACT NO.7 OF 2011, and PEU CIRCULAR NO.1/2025

- This circular has been issued in terms of Section 20 (c) as read with Section 66, 46 (2), 48 (2) and 57 (7) of the Public Procurement Act No.7 of 2011, and the PEU Circular No. 1 of 2024. The Act provides for the payment of fees for all services rendered by the Agency. The Act also provides for the payment of fees for administrative review and appeals against suspension from tenderers and suppliers.
- 2. This circular is an amendment to fees of the following circulars:
 - ESPPRA CIRCULAR NO.1/2024
- 3. The new schedule of fees shall be as follows:

i) FEES FOR LODGING APPLICATIONS FOR ADMINISTRATIVE REVIEW

- (a) 0.5% of the evaluated contract price offered by the review or administrative review applicant to the procuring entity in the procurement proceedings;
- (b) 0.5% of the value of the contract concerned in the case of an appeal against suspension;
- (c) Subject to a minimum fee of E5,000.00 if the percentage fee is lower than E5,000.00; and
- (d) Subject to a maximum fee of E100,000.00 if the percentage fee is higher than E100,000.00.
